November Meeting Report

The November MARA general meeting was called to order at 1930 on Wednesday the 14th by President Bill N1UZ.

The minutes of the October meeting were accepted as printed in the November W1/GaZette.

Pauline KB1JXJ reminded everyone of the holiday dinner at Bootleggers Restaurant in Lunenburg on Sunday, December 2, 1pm. The cost for food is \$20 per person.

Vice President (KB1LRL):

Concerned about the repeater situation; there has been lots of noise on the repeater.

The repeater has trouble with weak signals.

Norm W1BYH reported that he has tuned a bandpass filter to put in front of the receiver. He plans to install this on Nov 15. There have been no filters in the receiver as the current temporary repeater at his site was originally only expected to be in use for a few weeks. Norm believes that the problems with the current (temporary) repeater are primarily desense, not interference.

Gary K1YTS reports that he now has the Club repeater running in his garage and is trying to locate the problem the repeater has had in low temperatures. He believes he has identified the circuit that is sensitive and now needs to isolate the component. He may bypass the front panel connectors that were added-on.

Ray suggests that we use the 147.315 repeater (PL 100) as a backup, especially for the Montachusett Emergency Net.

Bill N1UZ replied that the Emergency Net should use simplex on 145.45 when the repeater is not working.

Ray reported that the Field Day results have been published. W1GZ scored 727 overall with 2300 points. He would like the Club to break 3000 in 2008.

Ray also reported that the October NEAR-Fest in Deerfield was fun. Tom AB1GF sold everything he had taken to the hamfest.

Charlie KT1I felt that NEAR-Fest was better than HossTraders.

Bill N1UZ reported that 6 to 8 MARA members went to the NVARC meeting on

October 18 to help with the QSL card sort. He gave great praise for KD1LE's sorting boxes.

Bill noted that there will not be a meeting on the 2nd Wednesday of December; instead, the December meeting will be held during the holiday party on December 2. The January meeting speaker has been scheduled; Ann Santos WA1S will speak on the Kure Island DXpedition. [Ed Note: see Ann's web site http://home.tiac.net/~wa1s/]. As always during the winter months, listen to 145.45 for snow cancellation.

Bill reports that he has contacted with the Westminster Board of Selectmen for permission to use the Westminster Town Commons for Field Day 2008. No site use permit is needed but the Fire Chief wants to verify the fire rating of the cooking tent.

Norm W1BYH notes that the ARRL Frequency Measuring Test takes place just after the Club meeting. W1AW transmits on 40, 80, and 160 meters at a precise frequency. The goal of the test is to read their frequency as accurately as you can. Here, accuracy is measured in fractions of a Hertz; .1 to .01 Hz.

Gordon N1MGO announced that Bette Liljengren of Greenville NH has joined MARA.

The raffle was won by Al KA1AKD.

Bill N1UZ announced that Paul WR1X is collecting books to send to military personnel stationed overseas. The program is called "Books for Soldiers". Contact Bill if you have anything to contribute.

The meeting adjourned at about 2015 at which time Scott Andersen NE1RD spoke about his "100 pound" DXpedition to Montserrat.

Hams Activated in Northwest Flooding

For the past week, the wake of fierce storms have ravaged the Pacific Northwest, killing at least seven people and leading to widespread flooding and mudslides that shut down roads and highways. Tens of thousands of residents remained without power after the storms struck Oregon. The governors of Washington and Oregon declared states of emergency, which could speed relief efforts in flood-hit areas.

Throughout it all, Amateur Radio operators were there to help. In Oregon, after a visit Tuesday to Vernonia, Governor Ted Kulongoski said, "I'm going to tell you who the heroes were from the very beginning of this...the ham radio operators. These people just came in and actually provided a tremendous communication link to us." The Oregon Office of Emergency Management said the radio operators were tireless in their efforts to keep the systems connected. When even state police had difficulty reaching some of their own troops, ham radio worked, setting up networks so emergency officials could communicate and relaying lists of supplies needed in stricken areas.

Amateur Radio's role in again providing communications when other systems were destroyed or overloaded was not missed by the media. Many TV, radio and newspaper items have appeared, praising the hams and noting their service to the communities. Portland's KATU Channel 2 spotlighted the role



In Oregon, ARES is still providing communications to the coast, with more than 60 volunteers working at the coast and many more at points in between.

According to Sally Jones, Administrator for the Columbia 911 Communications District, "The 911 lines that would normally be answered in Seaside and Astoria for callers in Clatsop County were diverted by the phone company to the Columbia 911 Communications Center on a temporary emergency basis. The emergency phone calls are being taken by Columbia 911 staff who are relaying the information via Columbia County and Clatsop County Amateur Radio Emergency Services volunteers to the police fire and emergency medical dispatchers in Clatsop County, who then are activating Clatsop County first responders." Clatsop County's 911 service also went down in the storm, but officials there relied on ham radio operators to transmit messages, including information about people in need.

The Thurston County Department of Emergency Management activated ARES on Tuesday, December 4 to support ongoing flood evacuation operations in southwest portion of the county. The team staffed the County Emergency Operations Center's radio room in Olympia and manned sites at the Rochester Fire Station, various evacuation centers as well as landing zones for the helicopter rescue teams.
